### CAMPER RULES:

1. Camping cost is **\$250/300/350** per camper for all week of the fair. **ATTENTION: NO PARKING OF CAMPER FRIDAY EVENING. CAMPER PARKING STARTS SATURDAY MORNING AND THOSE THAT DO NOT ABIDE BY THIS RULE WILL BE BANNED FOR THREE YEARS. Campers will be parked from 8:00 a.m. to 8:00 p.m. Saturday and Sunday before the fair.**
2. Space prices do **not** include fair entry or parking spots. Everyone staying in campers must have and hold a ticket for the week of the fair. Tickets **must** be membership tickets, season tickets, Jr. Fair passes or Jr. Fair advisor passes. **Before any camper is parked, the occupants must have a camping permit and contact a Director in charge of camping. Tickets will need to be purchased before camping permit is issued. Camping permits must be visible from the outside.**
3. All fire lanes must be kept open at all times.
4. Quiet hours begin at **12:00 midnight**. Please consider your neighbors.
5. All trash is to be placed in the proper containers. **No** sewer or gray water permitted to be discharged on ground.
6. **No** outside refrigeration units.
7. Electric cords used on campers must be in good working order.
8. Trailers must be parked tongue out. Motor homes with motor out. (By order of Fire Marshall)
9. The above rules will be enforced by the Guernsey County Agriculture Society. The Society reserves the right to cancel, reject or refuse any persons or campers and will **not** be held responsible for accidents of any sort.
10. To the fullest extent permitted by law, the Campers agree to defend, pay in behalf of, and hold harmless the Guernsey County Agriculture Society against any and all claims, demands, suits, losses, including all costs connected therewith, for any damage which may be asserted, claimed recovered against or from the Guernsey County Agriculture Society, its elected and appointed officials, employees, volunteers or all other workers in behalf of the Guernsey County Agriculture Society, by reason of personal injury, including bodily injury and death; and/or property damage, including loss of use thereof, which arises out of the alleged negligence of the Guernsey County Agriculture Society or the undersigned and is in any way connected or associated with this contract.
11. **NO ALCOHOL IN CAMPER AREA AND FAIRGROUNDS.**

**THOSE THAT DO NOT COOPERATE WITH THE ABOVE RULES AND FAIR BOARD DIRECTORS WILL BE ASKED TO LEAVE AND NOT PERMITTED TO RETURN. VEHICLES WILL BE TOWED AT OWNER'S COST. ALL ENTRANTS MUST READ AND SIGN THE FOLLOWING:** It is understood and agreed that the Guernsey County Fair, its Officials and Agents shall not be responsible for the loss, damage or injury to any person or animals which is caused directly or indirectly by any one for any reason. The undersigned also agrees to hold harmless the Guernsey County Fair and the Town of Old Washington, OH, for any expenses or liabilities, including attorney fees.
